The Mayor and Council of the Town of Golden Meadow met for their regular meeting on Monday, February 3, 2014 at 7:00 P.M. at the Town Hall 107 Jervis Drive, Golden Meadow, LA 70357.

Others attending were Salvador Gonzalez, Jr., Salvador Gonzalez, Sr., Jamie Liner, and Chief Reggie Pitre.

Mayor Joey Bouziga called the meeting to order at 7:00 P. M.

Councilman Lindberg Lorraine presented a motion and Councilman Priscilla Mounic seconded approving the minutes from the previous meeting and public hearing held on January 21, 2014. The Council unanimously approved the motion as presented.

Mr. Salvador Gonzalez, Jr. led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Mayor Joey Bouziga informed the Council no building permits or Occupational Licenses were submitted for approval.

Mayor Joey Bouziga presented the clean-up report as follows:

- Chad Duet – 119 Jefferson Street has not been cleaned. Town workers have not been able to cut and clean the property due to weather conditions. Mayor Joey Bouziga informed the Council he spoke with Mr. Chad Duet and he stated he was in the process of installing a fence around his property.
- John Parker – South Bayou Drive (Old Two Sisters) has been subpoenaed for court February 25, 2014.
- Athanase Borne C/O Irvin Cheramie – 130 Pelican Lane was subpoenaed for court February 25, 2014.

Mayor Joey Bouziga presented the dangerous building report as follows:

- Louis Griffin C/O Jerry Griffin – 143 Griffin Lane remains in a dangerous condition. Mayor Joey Bouziga informed the Council he is working to acquire more than one quote to demolish the building.
- Adval, Inc. – 133 Meadow Lane is in the process of being demolished.
- Dinah Stallings – 508 South Bayou Drive is in the process of receiving a letter from Attorney Bryce Autin.

Mayor Joey Bouziga presented the project report as follows:

- Sewer Phase IV is in the right-of-way stages.
- Sewer Phase V application for funding has been submitted to LCDBG.
- Seawall Phase I Repairs plans has been completed. Engineer John Plaisance is in acquiring quotes from contractors to complete the repairs.
- Seawall Phase II should be completed sometime in February.
- Seawall Phase III letter has been drafted requesting matching funds for the project.
- Frank's Supermarket Turnaround should begin soon.
- Fuel System Project should begin soon. The delay was due to the completion of the Street Resurfacing Project. The fuel tank and part of the system was ordered in December, 2013.
- Basketball Pavilion contracts are awaiting President Randolph's signature.
- Town Hall Improvements Project should begin soon.

Attorney Bryce Autin submitted his report in writing due to his absence.

Mayor Joey Bouziga informed the Council he contacted the owner of the house located on Pierce Street being used as a bunkhouse. The property owner informed Mayor Joey Bouziga his tenants would be moving out of the house.

Mayor Joey Bouziga informed the Council he will discuss property adjacent to the Town property with owner Mark Boudreaux.

Councilman Jody Cheramie presented a motion and Councilman Priscilla Mounic seconded adopting Ordinance 474 amending Ordinance 472 providing for the enforcement of certain traffic violations by photographic vehicle speed enforcement system and providing for civil penalties for those certain traffic violations enforced by a photographic vehicle speed enforcement system. The Council unanimously approved Ordinance No. 474 with Councilman David Adams being absent.

Councilman Priscilla Mounic presented a motion and Councilman Willis Toups seconded approving the police officer detail rate be increase from \$22.00 per hour to \$30.00 per hour being divided \$28.00 per hour for the officer conducting the detail and \$2.00 per hour for the Town for the use of the police vehicle. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented the 4th quarter finance report.

Mayor Joey Bouziga requested adding a parade permit to the agenda. With no audience member or Council member in opposition of the addition, Councilman Priscilla Mounic presented a motion and Councilman Willis Toups seconded approving Mayor Joey Bouziga add the aforesaid to the agenda. The Council unanimously approved the motion as presented. Councilman Lindberg Lorraine presented a motion and Councilman Willis Toups seconded approving a parade permit for the Krewe of Les Petite Lions to roll through the Town of Golden Meadow beginning on Armand Street ending at the south end of town on Sunday, February 16, 2014 at 1:00 P.M. The Council unanimously approved the motion as presented.
