The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, June 18, 2012, at 7:00 P.M., at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Bouziga called this meeting to order at 7:00 P.M.

Councilman Mike Billiot presented a motion and Councilman Priscilla Mounic seconded approving minutes from the previous meetings held on June 04, 2012. The Council unanimously approved the motion as presented.

Councilman Frank Boura presented a motion and Councilman Priscilla Mounic seconded approving Resolution No. 1505 authorizing a contract agreement with the State of Louisiana, Office of the Governor FY "11-12" Louisiana Government Assistance Program.
