The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, December 3, 2012 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Councilman Mike Billiot presented a motion and Councilman Priscilla Mounic seconded approving the minutes from the previous meeting held on November 19, 2012. The Council unanimously approved the motion as presented.

Councilman David Adams led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Mayor Bouziga informed the Council no building permits were submitted for approval.

Councilman David Adams presented a motion and Councilman Jody Cheramie seconded approving an Occupational License for Guidry's Meat Market, LLC, 704 North Alex Plaisance Blvd. owners Simon and Stephanie Guidry. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented a report from the South Central Planning Building Inspector declaring 143 Griffin Lane a dangerous building. Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving a dangerous building letter be sent to the property owner. The Council unanimously approved the motion as presented.

Councilman Mike Billiot presented a motion and Councilman Jody Cheramie seconded approving the 2013 meeting schedule. The Council unanimously approved the motion as presented.

Town Engineer John Plaisance presented the project updates as follows:

- Sewer Phase III – Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving Change Order No. 1 required due to the re-routing of the sewer lines. The Council unanimously approved the motion as presented.
- Sewer Phase IV – Right-of-Way experts are beginning.

- Seawall Phase II – Mayor Joey Bouziga stated we are still waiting on a decision from FEMA. Mayor Joey Bouziga stated he would try to schedule a meeting sometime this week.
- Seawall Phase III – Working on Engineering Contracts.
- Oakridge Park Waterlines Phase I and Phase II are almost complete.
- Frank's Supermarket Crossover – paperwork has been submitted to the state.
- Gas and Diesel Tanks – This project should begin sometime in January.
- Repairs to Seawall Phase I – a meeting will be schedule with Mayor Joey Bouziga and Councilman Frank Boura to discuss the repairs.

Councilman David Adams presented a motion and Councilman Mike Billiot seconded approving Resolution No. 1529 authorizing Mayor Bouziga signs and enters into a Cooperative Endeavor Agreement with South Central Planning and Development for police radios. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council he received several complaints regarding vehicles parked along Oakridge Drive. Mayor Joey Bouziga stated vehicles being parked along Oakridge Drive are creating problems for large trucks. Councilman Mike Billiot presented a motion and Councilman Jody Cherie seconded approving "NO PARKING" signs be installed along Oakridge Drive. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council he requested and was approved funding in the amount of \$100,000.00 from the Lafourche Parish Government to construct a pavilion with lights over the basketball court in Oakridge Park.

Mayor Joey Bouziga informed several problems are being addressed regarding the Street Resurfacing Projects Phase I through Phase III.

Mayor Joey informed the Council the Official and employee banquet will be held on Thursday, December 20, 2012 at 6:00 P.M.

Mayor Bouziga requested adding parade permit to the agenda. No audience comments were presented. Councilman Frank Boura presented a motion and Councilman David Adams seconded approving a parade permit for the Golden Meadow Family Fishing Rodeo Christmas Parade scheduled on Saturday, December 8, 2012 at 2:00 P.M. beginning at Armand Street and ending at the Town Hall. The Council unanimously approved the motion as presented.

Mayor Bouziga wished all candidates luck for Saturday's runoff election.

Councilman Frank Boura requested Mayor Joey Bouziga proceed with the Golden Meadow Rotary Grant. Mayor Joey Bouziga stated he did not know Rotary was ready but he would contact them.

Mayor Joey Bouziga requested audience comments.

Mr. Greg Terry informed the Council several Toys for Tots boxes were placed around Town and the toys would be used for local children 1 year old to 12 years old.
