The Mayor and Council of the Town of Golden Meadow met for their regular re-scheduled meeting on Monday, May 9, 2011 at 7:00 P.M.

Mayor Bouziga called this meeting to order at 7:00 P.M.

Councilman Mike Billiot presented a motion and Councilman Frank Boura seconded approving the minutes from the Public Hearings and Town Meeting held on April 18, 2011. The Council unanimously approved the motion as presented.

Councilman Jody Cheramie led everyone in reciting the Pledge of Allegiance and prayer.

Mayor Bouziga informed Councilman Boura he met with DOTD regarding the problem on LA 1 near Chisom Piccou. Mayor Bouziga stated the Lafourche Parish Water District repaired approximately nine water leaks along LA 1 and are responsible for the repairs to the road. Mayor Bouziga informed the Council the Water District has hired a contractor to conduct the repairs.

Martha Cazaubon briefly explained the LCDBG Grant Application process. After a brief discussion Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving Resolution 1454 authorizing the submission of an application under FY 2012-2013 Louisiana Community Development Block Grant Program for Sewer. The Council unanimously approved the motion as presented.

Mayor Bouziga thanked Martha Cazaubon for her outstanding work for the Town of Golden Meadow. Councilman Jody Cheramie presented a motion and Councilman David Adams seconded approving a "Thank You" letter be sent to Kevin Bellanger regarding Martha's outstanding work. The Council unanimously approved the motion as presented.

Mayor Bouziga informed the Council Phase II of the Street Resurfacing Project is approaching completion and Phase III should begin soon.

Mayor Bouziga requested Sabrina and Kevin Cheramie be placed on the next agenda.

Councilman Jody Cheramie presented a motion and Councilman Mike Billiot seconded approving a can shake application to benefit a cancer patient on May 21, 2011 from 8:00 A.M. to 12:00 Noon. The Council unanimously approved the motion as presented.

Mayor Bouziga requested adding Resolution No. 1456 to the agenda regarding the Municipal Infrastructure Program Grant application and the South Sewer Plant Project. No audience comments were presented. Councilman Mike Billiot presented a motion and Councilman Priscilla Mounic seconded approving Mayor Bouziga add the MIP Grant application and the South Sewer Plant Project to the agenda. The Council unanimously approved the motion as presented.
